



## KWCUSA 2020 Chapter Director Agreement

US World Partners/National Director Joshua Baron & National Producer Catie Baron of Epic Performance Productions, henceforth known as "National Director" and \_\_\_\_\_ henceforth known as "State Chapter Director" for the state of \_\_\_\_\_ enter into this agreement freely and willingly on this date: \_\_\_\_\_.

The covenants of this agreement are as follows:

### The US Director:

National Director agrees to provide State Chapter Director with competition rules and guidelines along with digital files for providing all scoring paperwork to be able to independently run a Karaoke World Championships qualifying contest season for 2020 within their assigned state(s), as well as marketing materials and personalized support for the **KWCUSA 2020** henceforth known as "Event".

### Participation Fee

State Chapter Director agrees to provide National Director with a **\$1500 participation fee** for the rights to hold KWC licensed competitions in that assigned state chapter for the **KWCUSA 2020 competition year**. Chapter director agrees to follow the set KWC production guidelines and deadlines provided by National Directorship. State Chapter Director agrees to source out qualifying venue team sponsors within their assigned state to hold qualifying KWCUSA events and help direct these events within that state. State Chapter Director will provide the necessary KWCUSA Licensed Team Venue Kit and assist in securing judges for all enrolled venue team trials in that state. Venue trial events will all lead up to one State Chapter Finals event, selecting the top 5-6 singers in that state from the competing teams to send on to the national finals event. [1<sup>st</sup> place winner hotel room prize p is included in these fees]. State Chapter Director will lead the members of their State Chapter team to the US National Finals Competition as a connection between the contestant and national event planning committee. **State Chapter Director receives 50% of every official team venue sponsorship fee collected within their state or (25% of the fee if an area Charter Director is appointed for that State Chapter)** These funds are meant to help fund the state budget for the qualifying contests prize packages and state finals event costs. **State Chapter Director will keep 50% of every \$15 entry fee paid by each contestant in that state** trying out to help fund the state budget for all other expense items such as travel, judge meals, advertising, printing, etc.

### Credit

In exchange for this sponsorship, National Director agrees to:

- **Provide written rules, guidelines, documents, and personalized support for your state chapter**
- **Provide marketing materials to share with and secure venue teams**
- **Provide personalized KWCUSA State Chapter Director business cards**
- **Promote you as the official State Chapter Director and your states participating sponsor venue teams on the official KWCUSA website and Facebook pages and any other applicable areas**
- **Take care of booking lodging at the National Finals event for the first place winner from your state chapter finals to be part of the prize package offered within every state chapter.**
- **Provide Certificate for winners moving on along to Nationals with medals & trophies for State Chapter Finals event.**

### Delivery

National Director agrees that the item(s) listed above will be delivered to Company as dictated by the states qualifying schedule and timeline. Initial guidelines and digital documents to begin will be delivered no later than 10 days from the date of signing.

### Relationship

This agreement represents the only relationship between Company and Sponsor. No other relationship between the two entities exists, implied or otherwise.
